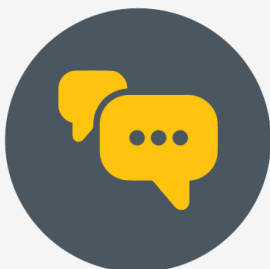

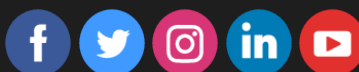
We have a team of staff dedicated to managing the needs of the employees from our company groups – and then we can extend membership to their family, and their family, and so on!
