

RULES

- 1. Purpose of Contest:** To select one winning design created by a child that is a member of Trax Credit Union (Trax) and reproduce it as the Holiday Card for Trax. Eligible members are invited to draw a card that depicts their interpretation of the theme “Max and Rex Open Presents!”
- 2. Eligibility:** Trax members age 14 and under as of October 1, 2025, are eligible to participate.
- 3. How to Enter:**
 - a. Beginning October 1, 2025, the entry form will be available at www.traxcu.com or may be picked up from a Trax branch while supplies last.
 - b. Pencil, pen, crayon, color markers and paints are permitted. Computer or other machine-generated artwork will not be accepted. Artwork must be original and shall not infringe upon the intellectual property rights of any third party, including by way of example and not by limitation, any copyright, trademark, or patent rights belonging to any third party.
 - c. Only one entry per child. All entries must be received by November 7, 2025, at 12pm EST.
 - d. Drop your entry off at an office (**do not fold the entry**). If you cannot drop the entry of at an office, affix correct first-class postage on an envelope of appropriate size to accommodate the completed entry form without folding and mail to: **Trax Credit Union, Holiday Card Contest, 3710 N. 50th St., Tampa, FL 33619.**
 - e. Upon entry, all cards, artwork, and related intellectual property rights, including but not limited to copyright, become the property of Trax without compensation to the entrant. The entry forms will not be returned to the entrant. Entries may, throughout the Contest and thereafter, be distributed, used, exhibited, donated, auctioned, and/or displayed by Trax (including, but not limited to, reproduction and display on the Trax website, and any social media sites related to Trax), and will be disposed of at the discretion of Trax, all without compensation or notice to entrant.
- 4. Prizes:**
 - a. One Grand Prize and one Runner-Up Prize will be awarded.
 - b. Grand Prize entry for Trax Contest is a cash award of \$100.00. The Runner-Up award is \$ 50.00 cash.
 - c. Winner’s parents or legal guardians will be required to sign a Release Authorization Form. Receipt of the signed document is a condition of delivery of the respective prize to each winner.
 - d. The Grand Prize-winning entry will be printed, reproduced and subject to interpretation and modification. Trax will have the exclusive right to reproduce the Grand Prize-winning card.
- 5. Winner Selection:**
 - a. Grand Prize Winner: Entries will be judged by representatives of Trax on the creativity and quality of expression in depicting the theme “Max and Rex Open Presents!” The winner will be selected & notified by phone or mail on or about November 17, 2025.
 - b. Runner-Up Prize Winner: Representatives of Trax will select one winner based on their creativity and quality of expression in depicting the theme “Rex and his Reindeer!” The Runner-Up Prize winner will be selected and notified by phone or mail on or about November 21, 2025.
 - c. If a potential winner cannot be contacted, fails to sign and return the Release Authorization (referenced above), if any fact set forth in the form is determined to be false, or if the prize notification is returned as undeliverable, an alternate winner will be chosen using the same criteria described above. Subject to winner verification, the decisions of the judges are final. Odds of winning are based on the number of eligible entries received. For notification of the prize winner, send a separate, self-addressed, stamped envelope to Contest Winner List, Public Relations, Trax Credit Union, 3710 N 50th St., Tampa, FL 33619 on or before December 1, 2025.
- 6. Additional Terms and Conditions:**
 - a. Contest subject to all federal, state, and local laws and regulations. This contest is void where prohibited. Applicable taxes, if any, are the responsibility of the winners.
 - b. Entry constitutes agreement with all of the foregoing rules and terms, and also constitutes permission to use each respective winner and their parent’s or legal guardian’s name, likeness, contest card entry and information contained therein, artwork, statements, quotes, testimonials, photographs, and name of hometown for promotional purposes, including but not limited to posting of such information and reproduction and display of the winner’s card on Sponsor’s websites, except where prohibited by law. Failure to comply with the contest rules may result in the entrant’s disqualification.
 - c. Sponsors are not responsible for (1) lost, stolen, illegible, torn, damaged, folded, late, incomplete, or misdirected entries; (2) telephone, electronic, hardware or software program, network, Internet or computer malfunctions, failures or difficulties; (3) any condition caused by events beyond the control of Trax which may cause the Contest or the awarding of prizes to be disrupted or impractical of being completed; and (4) unauthorized human intervention in any part of the entry process or the Contest. No more than the stated number of prizes will be awarded.
 - d. Entry constitutes agreement to hold Trax, together with its respective directors, officers, and employees, harmless from and against any and all physical injury, damages, liabilities, losses, and expenses arising out of this Contest or acceptance or use of the prize(s). Winner assumes all liability for any injury or damage caused, or claimed to be caused, by participation in this contest or use of redemption of any prize.
 - e. Trax reserves the right to cancel, suspend, disqualify, and/or modify the Contest, if any fraud, technical failures, or any other factors beyond Trax’s control impairs the integrity or proper functioning of the Contest, as determined by Trax in its sole Trax’s failure to enforce any term of these Rules shall not constitute a waiver of that provision.
