Please remember that tax refund checks and electronic deposits can only be accepted if they are made payable to an account holder. Any checks or deposits made payable to a non-member cannot be processed and may be returned to the IRS.

If you have an IRA with the Credit Union, please remember that you are limited to one IRA rollover in a 12-month period per social security number across all IRAs. We will furnish the year-end balance of your IRA account (also known as the Fair Market Value) to the Internal Revenue Service as required.

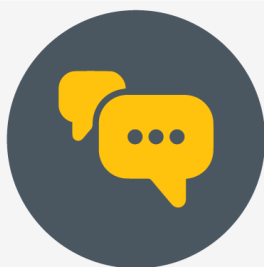
